This software end user license agreement ("EULA") is a legal agreement between you and IDRsolutions. Read it carefully before using the software. It provides a license to use the software and contains warranty information and liability disclaimers. By installing and using the software, you are confirming your acceptance of the software and agreeing to become bound by the terms of this agreement. If you do not agree to be bound by these terms, then do not use this software.

This EULA shall apply only to the JPedal developer libraries and / or the PDF to HTML5 software supplied by IDRsolutions herewith regardless of whether other software is referred to or described herein.

Definitions

In this agreement unless the context otherwise requires:

Grant of Licence

- 1. In consideration of the payment of the Licence Fee by the Licensee to the Company, the Company grants to the Licensee with immediate effect a perpetual, world-wide, royalty-free unlimited distribution licence to use, copy, modify and distribute indirectly through Distributors, or directly, the Licensed Program as part of a single named product (xxxx) and to possess and refer to the Program Documentation, subject to the terms and conditions set out herein.
- 2. Nothing in this Agreement will compel the Company to make Releases or New Versions available to the Licensee, except in order to attempt to remedy faults in the Licensed Program.
- 3. The Company agrees to provide (xxxx) all updates to the Licensed Program for a period of one year from the date of this contract.
- 4. End User License Agreement. When the Licensee licenses the Licensed Program as part of a (xxxx) Product to End Users, it shall do so pursuant to either an executed, "shrink wrap" or "click-through" Licensee or Distributor license agreement, in Licensee's discretion.
- 5. Source Code is made available to OEM / Enterprise customers solely for use in developing the **named product**.

Governing Law

This agreement is governed by and construed in accordance with English law. Both parties consent to the non-exclusive jurisdiction of the English courts.

Technical Support

- With effect from the date of purchase the Company shall provide technical support services by email to the Licensee in respect of the Licensed Program, as well as all updates to the Licensed Program for a period of TWELVE MONTHS. Additional periods of support may be purchased from the Company at additional cost.
- 2. If the support contract on a licence has expired when additional support is purchased, then IDRsolutions will back date the support start date to coincide with the expiration of the previous support agreement.
- 3. Upon request by the Licensee the Company agrees to use its reasonable endeavours to respond by email within 24 hours of receipt of a request (72 hours in the case of a weekend or public holiday) to diagnose faults in the Licensed Program and to use its reasonable endeavours to rectify such faults.
- 4. The Licensee agrees to supply the Company with a detailed description of any fault and the circumstances in which it arose forthwith upon becoming aware of the same.
- 5. Technical support services shall not include the diagnosis and rectification of any fault resulting from:
 - a. the improper use, operation or neglect of either the Licensed Program Materials or the equipment on which the software is loaded;
 - b. the failure by the Licensee to implement recommendations in respect of or solutions to faults previously advised by the Company;
 - c. any repair adjustment alteration or modification of the Licensed Program by the Licensee without the Company's prior written consent;
 - d. any breach by the Licensee of any of its obligations under any maintenance agreement in respect of the equipment on which the software is loaded;
 - e. the Licensee's failure to install and use in substitution for the previous version any New Version or Release of the Licensed Program within 30 days of receipt acceptance of the same by the Licensee;
 - f. the use of the Licensed Program for a purpose for which it was not designed;
 - g. the use of pdf files that contain features mentioned in the Implementation list in Appendix one, or features which are added to the pdf specification after the date of this agreement unless such features are supported by a new Release or a New Version provided to the Licensee by the Company.
 - h. The Company also reserves the right to charge for modifications to the Licensed Program which are made in order for the Licensed Program to correctly open a pdf file containing variations of the Adobe pdf specification that have not already been seen by the Company.

- 6. The Company agrees to supply the technical support services provided that:
 - a. the Licensee agrees to install and use any New Version or Release (in substitution for any earlier version or release) which is made available to the Licensee by the Company, subject to mutual agreement and acceptance testing by the Licensee.
 - b. The Licensee shall inform the Company of any changes made to the configuration of the Licensee program, or any other alterations made by the Licensee which materially impact upon the operation of the Licensed Program.

Property And Confidentiality In Licensed Program Materials

The Licensed Program Materials contain confidential information of the Company and all copyright trade marks and other intellectual property rights in the Licensed Program Materials are the exclusive property of the Company. The Company assumes mutual non-disclosure and confidentiality between parties.

All information provided to the Company by the Licensee shall be treated as commercially sensitive and will not be disclosed to other parties in any form without prior written agreement from the Licensee.

The Licensee shall not:

- 1. reverse compile, copy or adapt the whole or any part of the Licensed Program Materials for the purposes of correcting errors in the Licensed Program Materials;
- assign, transfer, sell, lease, rent, charge or otherwise deal in or encumber the Licensed Program Materials or use the Licensed Program Materials for any purpose other than as specifically set out herein, or
- 3. remove or alter any copyright or other proprietary notice on any of the Licensed Program Materials.

The Licensee shall:

- keep confidential the Licensed Program Materials and limit access to the same to those of its employees agents and sub-contractors who either have a need to know or who are engaged in the use of the Licensed Program;
- 2. inform all relevant employees agents and sub-contractors that the Licensed Program Materials constitute confidential information of the Company and that all intellectual property rights therein are the property of the Company and the Licensee shall take all such steps as shall be necessary to ensure compliance by its employees agents and sub-contractors with the provisions of this clause;
- 3. notify the Company immediately if the Licensee becomes aware of any unauthorised use of the whole or any part of the Licensed Program Materials by any third party; and
- 4. take reasonable steps to protect the confidential information and intellectual property rights of the Company in the Licensed Program Materials.

Limitation Of Liability And Indemnity

The Licensed Program Materials have been provided to the Licensee in its entirety prior to this agreement in order for the Licensee to evaluate and assess the suitability of the Software for the Licensee's purposes. The software is provided "as is" and as a result the Company takes no responsibility or liability for any loss or damage arising as a result of using this software.

IDRsolutions declares that no open-source software is incorporated into the licensed software. All program code is written by and owned by IDRsolutions. Additional open source software may be used to extend the functionality of the licensed software, but this is used at the licensee's discretion and risk. IDRsolutions makes no warranty or claim about the ownership or functionality of any third party libraries.

IDRsolutions respects and abides by international copyright laws. Customers must have copyright permission to use extracted content, fonts and images. Any use of the licensed software to infringe copyright law is done so at the licensee's risk. IDRsolutions will not indemnify clients for breaching copyright law.

Assignment

The Licensee shall not be entitled to assign or otherwise transfer this agreement nor any of its rights or obligations hereunder nor sub-licence the use (in whole or in part) of the Licensed Program Materials except with the prior written consent of the Company. Notwithstanding anything to the contrary herein, any transfer or sublicense between Licensee and any of its parents, subsidiaries or affiliates will be permitted without the written consent of the Company. Further, any sublicense to vendors for purposes of providing services to Licensee within the context of supporting the Licensee's Product shall not require prior written consent of the Company.

Appendix One

This document lists areas of the pdf specification which are not fully implemented by the JPedal library and sums up the issues involved

Note on pdf specification

The pdf specification was created by Adobe and there are currently 8 versions (1.0-1.7). This is a very large specification and leaves a number of undocumented and grey areas. JPedal currently implements about 85% of the Adobe specification.

Some pdf generators interpret the specification in different ways. Most of these should work with JPedal or can be made to work with minor modifications.
